Advocating for ecosystem and environmental research

The primary education and outreach activity of the AERC is the congressional briefing. Each year, leading researchers from our member institutions travel to Capitol Hill to speak to approximately 50 participants on pressing ecological and environmental issues. Their expertise can help inform resource management and shape public policy.

Helping our members be effective advocates

The AERC collaborates with the Public Policy Office of the American Institutes for Biological Science (AIBS). AIBS staff will help you schedule visits with congressional delegates, and they'll also help you learn how to more effectively communicate with legislators. With access to AIBS's Legislative Action Center and Public Policy Reports, you stay abreast of issues being discussed on Capitol Hill and make sure your voice is heard when proposed initiatives strike close to home.



Educating our members

The AERC hosts workshops to help scientists effectively convey the importance of environmental research to peers, prospective students, the general public, non-governmental organizations, and Congressional members and their staffs. We also organize and host symposia that bring together internationally renowned scholars to discuss key areas of ecosystem research. Our workshops and symposia enable researchers to share emergent research and collaborate with other scientists.

And educating others

Educating our members—through AERC-sponsored workshops and symposia—helps us better educate legislators, advocacy groups, and the public at large.
